IMPORTANT: This appliance should be inspected before use and at least once annually by a qualified service person.

More frequent cleaning may be required as necessary. It is imperative that the control compartment, burners and circulating air passageways of the appliance be kept clean.

DANGER: Carbon monoxide poisoning can lead to death!

CARBON MONOXIDE POISONING: Early signs of carbon monoxide poisoning resemble the flu, with symptoms including headache, dizziness, or nausea. If you experience these signs, the Fire Pit may not be working properly. Get fresh air at once! Have the Fire Pit serviced. Some people are more affected by carbon monoxide than others, including pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol, and those at high altitudes.

#### NATURAL GAS AND PROPANE:

To assist in detecting leaks, an odorant has been added to natural gas and propane. However, this odorant can fade, and gas may be present even though no odor exists. Make certain you read and understand all warnings. Keep this manual for reference. It is your guide to safe and proper operation of this appliance. WARNING: Any modification to this appliance or its controls can be dangerous.

- 1. This appliance, as supplied, is only for use with the type of gas indicated on the rating plate.
- 2. When this appliance is connected to a fixed piping system, the installation must conform to local codes, or in the absence of local codes, to the National Fuel Gas Code, ANSI Z223.1/NFPA 54, or the International Fuel Gas Code.
- Keep the appliance area clear and free from combustible materials, gasoline and other flammable vapors and liquids
- 4. Do not burn solid fuel in this appliance. Do not use this appliance to cook food or to burn paper or other objects.
- 5. <u>Children and adults should be alerted to the hazards</u> of high surface temperatures and should stay away to avoid burns or clothing ignition.
- 6. <u>Clothing or other flammable materials should not be</u> <u>hung from the appliance, or placed on or near the</u> <u>appliance.</u>
- 7. Young children should be carefully supervised when they are in the area of the appliance.
- 8. Do not use the appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.
- 9. Inspect the appliance before each use.


 Turn the appliance off and let cool before servicing, installing, repairing or covering. <u>Any guard or other</u> protective device removed for servicing the appliance must be replaced prior to operating the appliance. <u>Only a qualified service person should install, service,</u> or repair the appliance.

#### HIGH ALTITUDE INSTALLATION

The appliance is certified for installations up to 4500' (1372 m) above sea level. At this altitude range, no changes to the appliance are required. Please contact Paloform for information regarding installation above 4500' (1372 m).

#### LOCAL CODES

The installation of this appliance must conform with local codes, or in the absence of local codes, with the National Fuel Gas Code, ANSI Z223.1 • NFPA 54; National Fuel Gas Code; Natural Gas and Propane Installation Code, CSA B149.1; or Propane Storage and Handling Code, CSA B149.2, as applicable.




CAUTION: COR-TEN STEEL is designed to oxidize and form a protective layer that resists corrosion. This layer can take several months to stabilize depending on climate and weather conditions. Rust will bleed until it stabilizes.

Do not place Cor-Ten fire pits on surfaces that will be permanently damaged or stained by rust bleed.


Installation and repair should be done by a qualified service person. The appliance should be inspected before use and at least once annually by a qualified service person. More frequent cleaning may be required as necessary. It is imperative that control compartment, burner ports and circulating air passageways of the appliance be kept clean.


New Lava Rock may pop or crackle when first heated. This should subside after 30 minutes to one hour or more of operation. Maintain safe distance during this time.

#### TO ASSEMBLE THE FIRE PIT


- 1. Connect the Burner Assembly to the gas/propane supply using the supplied flex connector and following the instructions on page 8.
- 2. Carefully leak test all connections following the procedure on page 8.
- 3. Cover the burner evenly and completely with burner media (crushed tempered glass for natural gas; volcanic rock for propane). <u>Do not obstruct the pilot lighting port</u> with burner media! Use only burner media supplied by <u>Paloform!</u>
- 4. Follow the Initial Lighting Instructions on page 9. Make sure that the flame carries to all parts of the burner. Turn OFF the appliance and let it cool before proceeding to the next step.
- 5. Evenly distribute decorative topping (river stones, crushed glass or lava rock) on top of burner media. An uneven or excessively thick layer of topping can result in an uneven flame. Place boulders if applicable.
- 6. <u>Do not cover pilot shield. Keep the lighting port open and</u> <u>free of media. Do not use any media not supplied by the</u> <u>manufacturer!</u>



**DECORATIVE TOPPING** 





A gualified service person must connect the appliance to the gas supply. Follow all local codes.

#### CAUTION:

Use only new black iron or steel pipe. Internally tinned copper tubing may be used in certain areas. Use pipe of 1/2" diameter or greater to allow proper gas volume to Outdoor Fire Pit Burner. If pipe is too small, undue loss of pressure will occur.

#### INSTALLATION ITEMS NEEDED:

Before installing the Outdoor Fire Pit, make sure you have all items listed bellow:

- piping (check local codes)
- sealant
- manual shutoff valve
- adjustable (crescent) wrench or pliers
- sediment trap
- tee joints
- pipe wrench

#### INSTALLATION REQUIREMENTS

Installation must include a manual shutoff valve, union, and plugged 1/8" NPT tap. Locate NPT tap within reach for test gauge hook up. NPT tap must be upstream from the appliance.

Apply pipe joint sealant lightly to male threads. This will prevent excess sealant from going into pipe. Excess sealant in pipe could result in a clogged burner injector.

Install sediment trap in supply line as shown below. Locate sediment trap where it is within reach for cleaning and trapped matter is not likely to freeze.

A sediment trap prevents moisture and contaminants from entering the Outdoor Fire Pit controls. If a sediment trap is not installed, or is installed incorrectly, the unit may not work properly.


#### CHECKING GAS CONNECTION

WARNING: Test all gas piping and connections for leaks after installing or servicing. Correct all leaks immediately.

WARNING: Never use an open flame to check for a leak. Apply a mixture of liquid soap and water to all joints. Bubbles forming on joints while the gas is running indicate a leak. Correct all leaks at immediately.

Test Pressures in Excess Of 1/2 psi (3.5 kPa) This appliance and its individual shutoff valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures in excess of 1/2 psi (3.5 kPa).

Test Pressures Equal To or Less Than 1/2 psi (3.5 kPa) This appliance must be isolated from the gas supply piping system by closing its individual manual shutoff valve during any pressure testing of the gas supply piping system at test pressures equal to or less than 1/2 psi (3.5 kPa).



Failure to follow these instructions exactly may result in fire or explosion causing property damage, personal injury or loss of life.

Before operating the appliance, check all around the appliance area and on the surrounding floor for the smell of gas - some gas is heavier than air and may settle on the floor in the event of a leak. IF YOU SMELL GAS, follow the safety instructions on page 1 of this manual.

This appliance is equipped with an ignition device that automatically lights the pilot. Do not try to light the pilot manually.

The main gas valve in this appliance is not serviceable and does not have any control knobs or switches to operate. Do not remove the heat shields covering the valve and electronic devices. Do not try to repair or modify the valve, as doing so may result in a fire or explosion. Call a qualified service technician if you have any safety concerns.

Do not use this appliance if any part of it has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control that has been under water.

Improper installation, adjustment, alteration, service or maintenance can result in injury or property damage. For assistance or additional information, consult a qualified installer, service agency or the gas supplier.

#### INITIAL LIGHTING INSTRUCTIONS

Before placing burner assembly into a housing:

- 1. Purge air from the supply line.
- 2. Test for leaks in each of the following locations:
  - The gas supply line connection to the main valve;
  - The Burner connections and pilot;
  - All joints on the valve and control body;
  - · All field made joints and gas shutoff valves;
  - · All factory made joints and connections.
- 3. You may check for gas leaks using one of the following methods only:
  - Soap and water solution. <u>WARNING: If using a soap and water solution to test</u> for leaks, DO NOT spray the solution onto electronic parts;
  - An approved leak testing spray;
  - An electronic sniffer. NOTE: Remove any excess pipe compound from connections if using this method, as the compound can set off electronic sniffers.

#### DANGER: NEVER USE AN OPEN FLAME TO CHECK FOR GAS LEAKS.

Do not store or use gasoline or other flammable vapors or liquids in the vicinity of this appliance.

This appliance is designed to be connected to a power source that is controllable by a switch.

Do not connect 24 VAC AC adapter to a live power source.

#### **OPERATING INSTRUCTIONS**

- 1. STOP! Read the safety information on pages 1, 2 and 9 of this manual.
- 2. Turn off all electric power to the appliance.
- 3. Do not attempt to light the pilot manually.
- 4. Turn the manual gas control valve to the OFF position.
- Wait five (5) minutes to clear out any residual gas, then check for the smell of gas at and around the appliance, including near the floor. <u>If you smell gas,</u> <u>STOP! Follow the instructions on page 1 of this manual.</u> If you do not smell gas, continue to the next step.
- 6. Turn the manual gas control valve to the ON position.
- 7. Plug the supplied 24 VAC AC adapter into a 110V power outlet.
- 8. Connect the AC adapter to the AC input plug at the unit.
- 9. Place Burner Assembly in Housing
- 10. To ignite burner, turn on electric power to the appliance.
- 11. To turn off appliance, turn off electric power to the appliance.

#### TURNING OFF THE GAS TO THE APPLIANCE

- 1. Turn off all electric power supplied to the appliance if service is to be performed. Unplug the 24 VAC AC adapter from the power outlet.
- 2. If necessary, remove the burner from the housing to access the manual gas valve.
- 3. Turn the main manual shutoff valve to the full OFF position.

#### COVERING YOUR FIRE PIT

Paloform fire pits are designed to withstand rain and the elements under normal weather conditions.

- You do not need to use the cover on a day-to-day basis during "use" season.
- Do not cover the fire pit if it is wet. Allow it to dry before using this cover.
- The all-weather cover is recommended for winterization; seasonally, when the fire pit is not in use for extended periods; and during periods of extreme weather conditions.
- Note that concrete and corten steel age and form natural patinas over time.

WARNING: Turn off gas before servicing fire pit.

We recommend that a qualified service technician perform the following checkups at the beginning of each fire pit season.

If any irregularities are apparent with operation. Please refer to Troubleshooting guide, pages 12-13.

#### BURNER ELEMENT AND PILOT


Inspect the burner at regular intervals at least twice a year. Keep the burner and pilot area clean by vacuuming or brushing. Make sure the burner porting and burner air openings are free of obstructions at all times. Remove pilot cover to inspect pilot.

Remove topping from top of burner ring and Inspect area around the burner. Remove any lint or foreign material with a brush or vacuum cleaner.


#### PILOT FLAME

FLAME SENSOR


The flames from the pilot should be visually checked as soon as the unit is installed, and periodically during normal operation. The pilot flame must always be present when the fire pit is in operation. The pilot flame has two distinct flames: one engulfing the flame sensor and the other reaching to the main burner.





This said, fires pit's are mechanical appliances that are installed in uncontrolled and unpredictable environments. For this reason it is critical that your unit be inspected by a qualified service technician regularly, dependent on use and site conditions, but at minimum once per year. This will ensure that it receives the type of general cleaning and maintenance that will maximize its performance and lifespan. Furthermore, there are various "wear" components which have a limited lifespan due to the fact that their function is to sustain extreme conditions. Over the functional life of your fire pit, you can expect that parts such as pilots, control devices and valves, may need to be replaced periodically. Materials such as cast concrete and Corten Steel are expected to weather naturally over their lifetime and changes in appearance are normal and do not constitute failure in the materials.

#### WARRANTY - This product is warranted to the original owner, subject to proof of purchase:

Paloform warrants the components and materials in your appliance to be free from manufacturing and material defects for a period of one year from date of delivery. During this time, if any of the components in the appliance are found to be defective in materials or workmanship, Paloform will, at its option, replace or repair the defective components at no charge to the original owner. Paloform will also pay for reasonable labor cost incurred in replacing or repairing such components. Any products presented for warranty repair must be accompanied by a dated proof of purchase.
