**CARBON MONOXIDE POISONING:**

Early signs of carbon monoxide poisoning resemble the flu, with symptoms including headache, dizziness, or nausea. If you experience these signs, the Fireplace may not be working properly. Get fresh air at once! Have the Fireplace serviced. Some people are more affected by carbon monoxide than others, including pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol, and those at high altitudes.

**NATURAL GAS AND PROPANE:**

To assist in detecting leaks, an odorant has been added to natural gas and propane. However, this odorant can fade, and gas may be present even though no odor exists. Make certain you read and understand all warnings. Keep this manual for reference. It is your guide to safe and proper operation of this appliance.

**WARNING:** Any modification to this appliance or its controls can be dangerous.

Read instructions before installation and use.

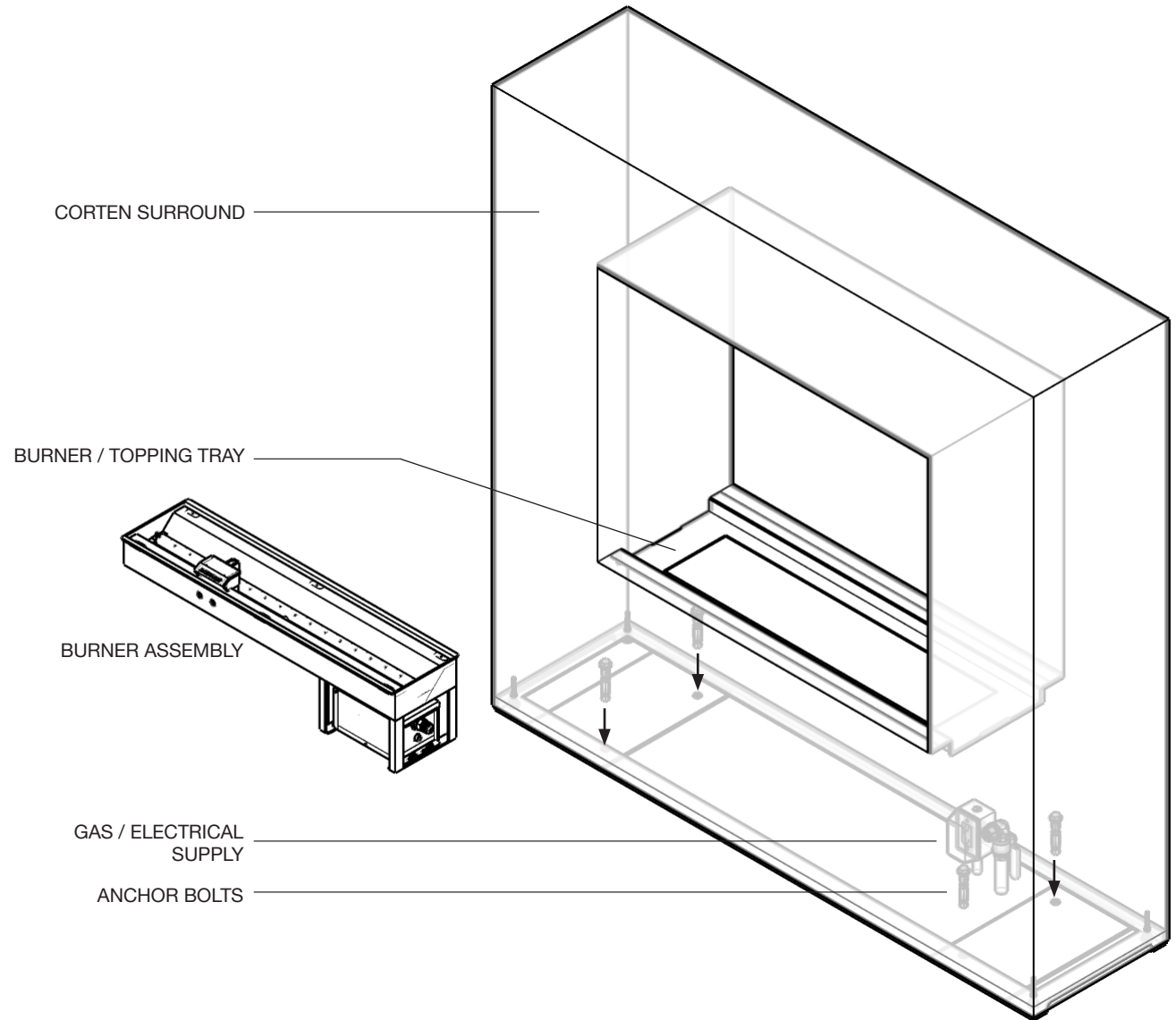
1. This appliance, as supplied, is only for use with the type of gas indicated on the rating plate.
2. This appliance is intended to be connected to a fixed piping system. The installation must conform to local and/or national codes.
3. Never leave the fire unattended.
4. Keep the appliance area clear and free from combustible materials, gasoline and other flammable vapors and liquids
5. Use only the type of gas that is specified by the manufacturer.
6. Do not burn solid fuel in this appliance. Do not use this appliance to cook food or to burn paper or other objects.
7. Children and adults should be alerted to the hazards of high surface temperatures and should stay away to avoid burns or clothing ignition.
8. Clothing or other flammable materials should not be hung from the appliance, or placed on or near the appliance.
9. Young children should be carefully supervised when they are in the area of the appliance.

10. Do not use the appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.
11. In case of violent wind particular attention must be taken against the tilting of the appliance.
12. Inspect the appliance before each use.
13. Do not move the appliance when in operation. Shut off gas at source before moving the appliance
14. Turn the appliance off and let cool before servicing, installing, repairing or covering. Any guard or other protective device removed for servicing the appliance must be replaced prior to operating the appliance. Only a qualified service person should install, service, or repair the appliance.

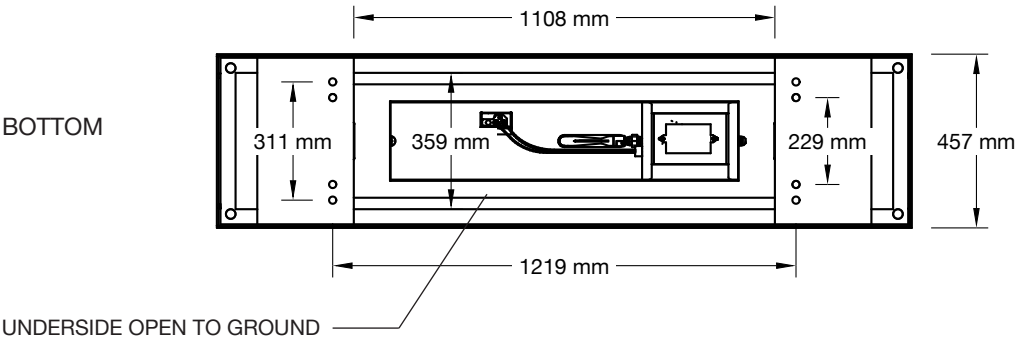
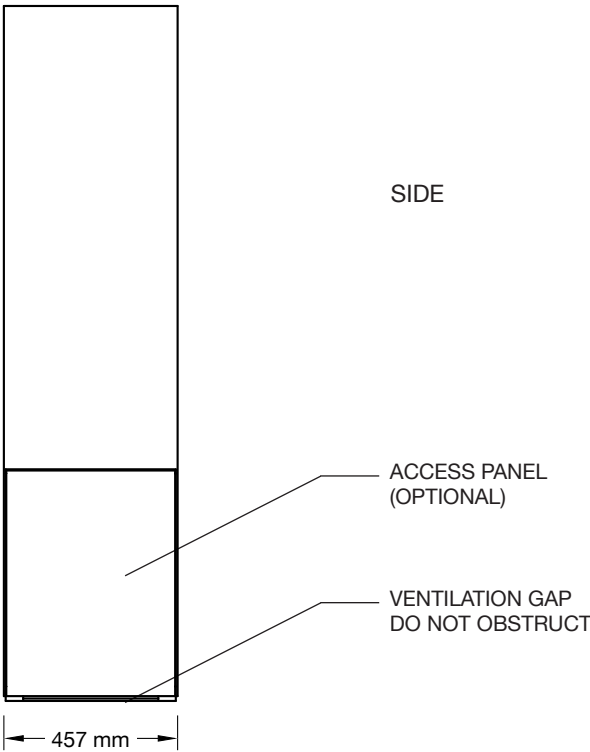
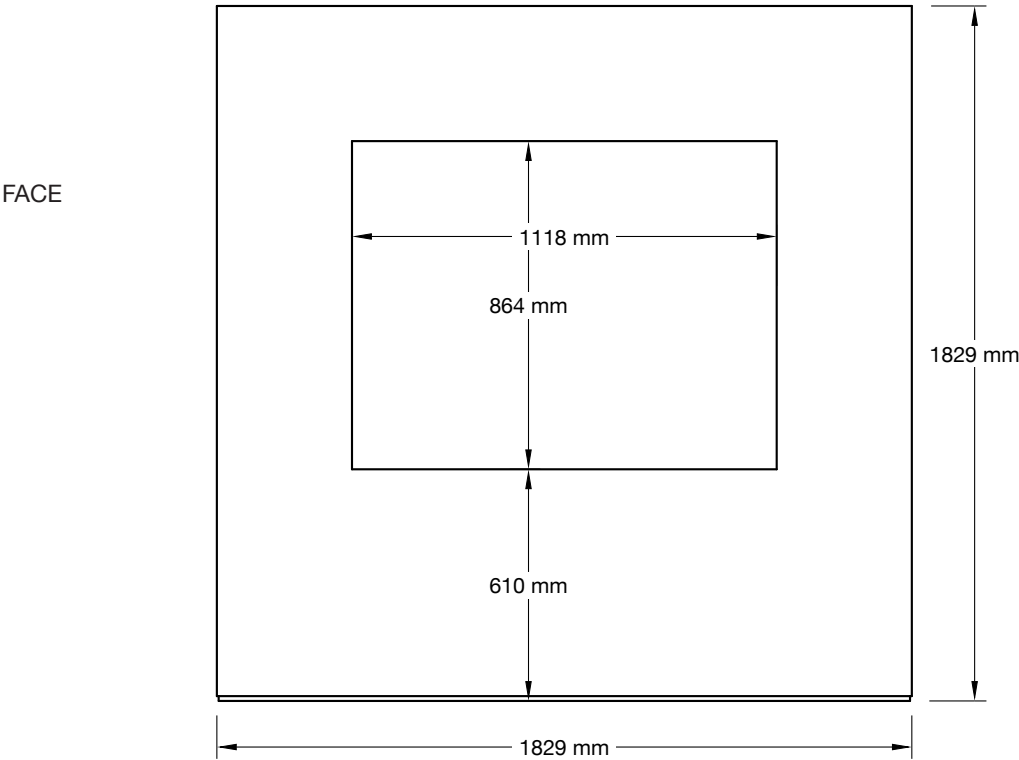

1. UNPACK: Account for all parts (p. 14-15)

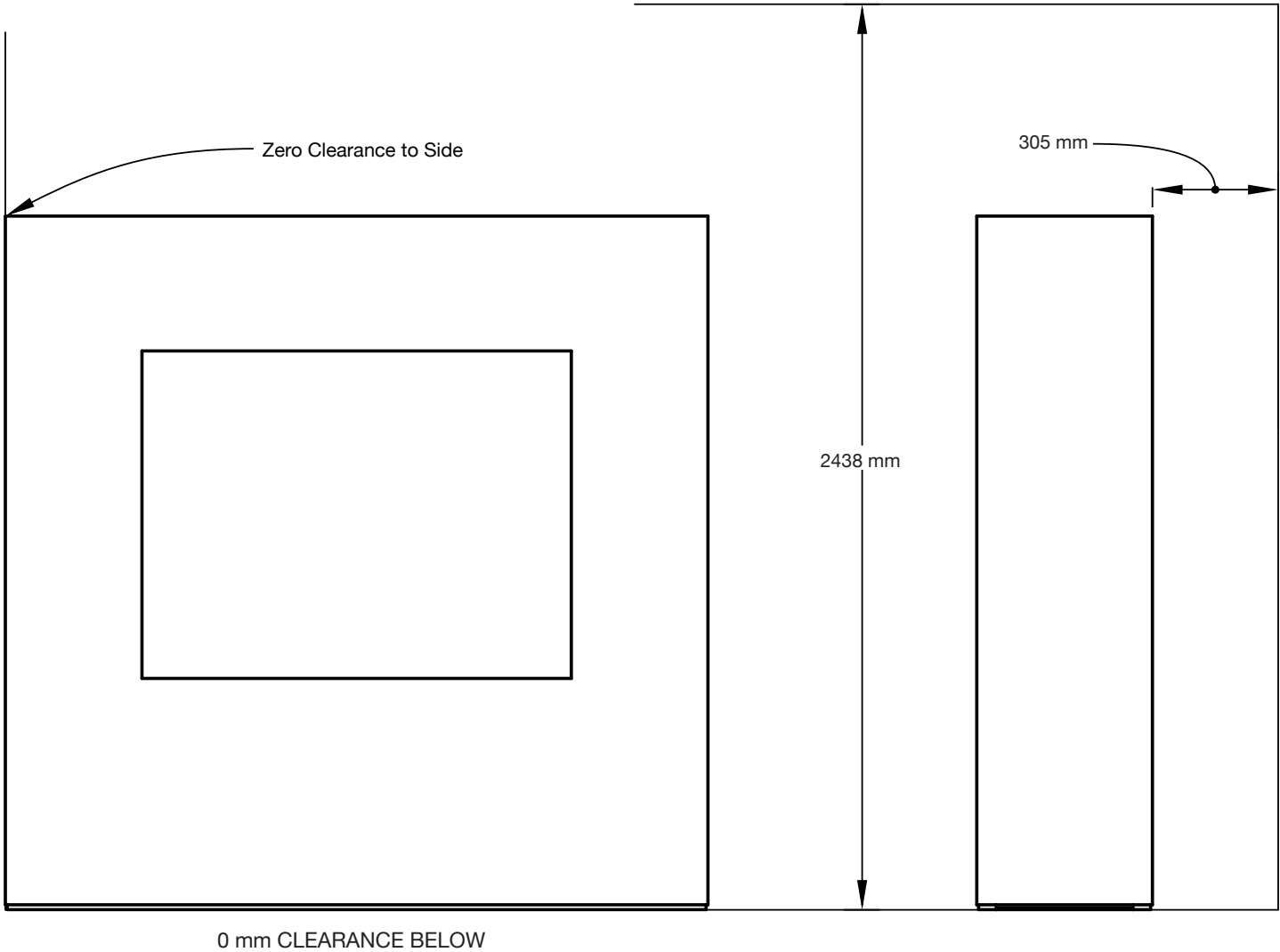


COR-TEN STEEL is designed to oxidize and form a protective layer that resists corrosion. This layer can take several months to stabilize depending on climate and weather conditions. Rust will bleed until it stabilizes.

Do not place Cor-Ten fireplaces on surfaces that will be permanently damaged or stained by rust bleed.

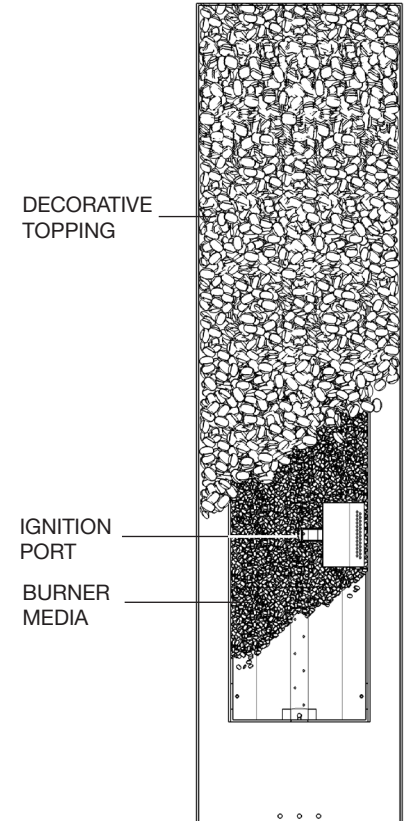
Installation and repair should be done by a qualified service person. The appliance should be inspected before use and at least once annually by a qualified service person. More frequent cleaning may be required as necessary. It is imperative that control compartment, burner ports and circulating air passageways of the appliance be kept clean.

## CAUTION:

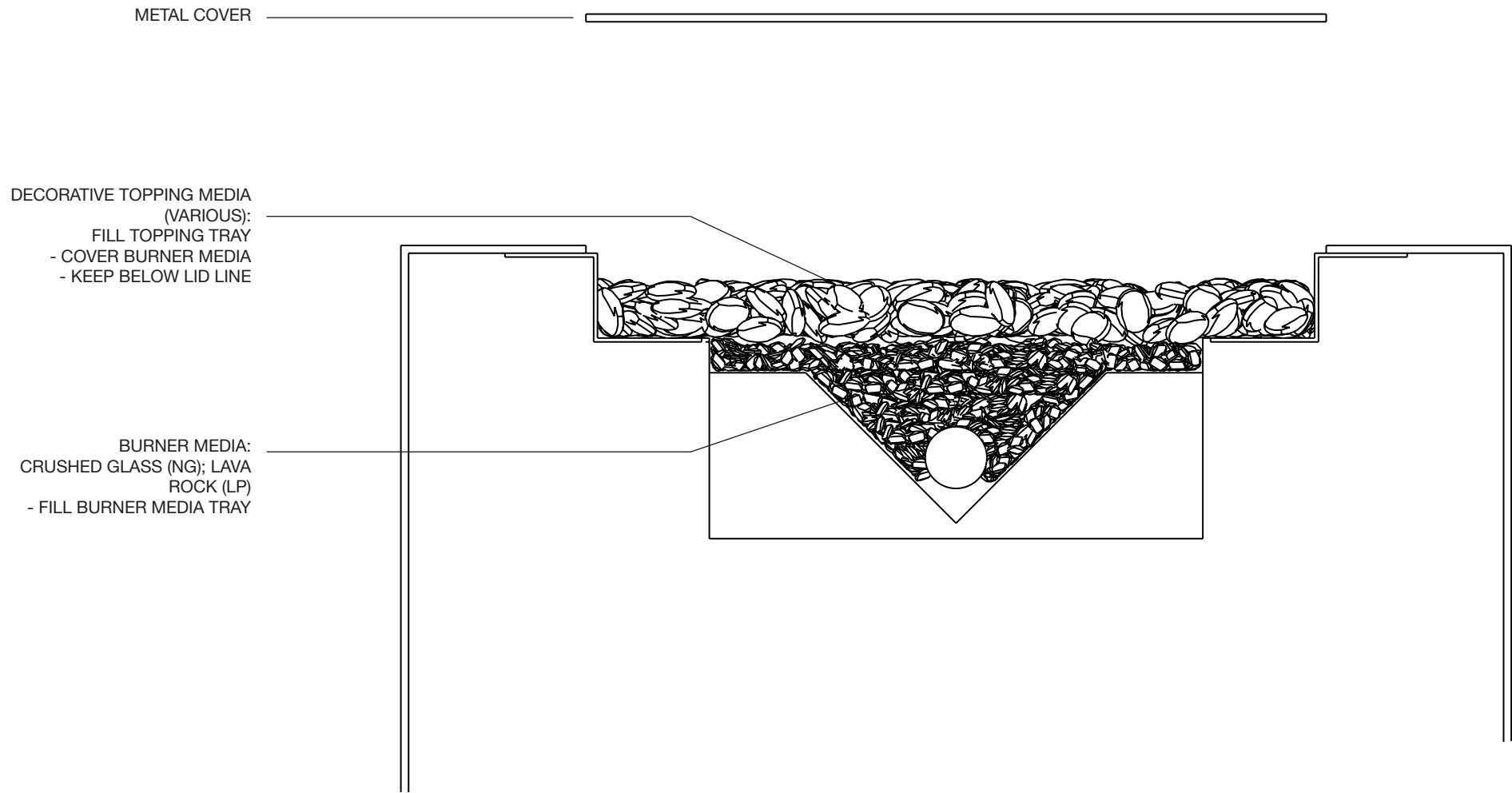
New Lava Rock may pop or crackle when first heated. This should subside after 30 minutes to one hour or more of operation. Maintain safe distance during this time.

## TO ASSEMBLE THE FIREPLACE

1. Ensure the fireplace surround is anchored per specifications.
  2. Connect the Burner Assembly to the gas supply using the supplied flex connector, following the instructions on p 9.
  3. Carefully leak test all connections following the procedure on p 9. Check the air shutter on venturi. For NG it is sealed. For LP it is fully open (see part 2a, pg 13)
  4. Fill the burner trough evenly with burner media (crushed tempered glass for natural gas; volcanic rock for propane). Do not obstruct the pilot ignition port with burner media! Do not use media not supplied by Paloform!
  5. Place the burner assembly on a stable surface. Ensure burner is level.
  6. Follow the Initial Lighting Instructions on page 10. Make sure that the flame is even along the burner length and appliance is fully operational and safe for use. Turn OFF the appliance and let it cool before proceeding to the next step.
  7. Carefully lift the burner and place it in the fireplace body. (See p 3)
  8. Place and evenly distribute decorative topping media (lava rock or tempered glass pebble) on top of burner media. (See page 7). Decorative media should be brought level with the top of the pilot cover. An uneven or excessively thick layer of topping can result in an uneven flame.
- Do not obstruct PILOT IGNITION PORT!
9. Correct flame appearance:



CAUTION: Do not use any media over the burner that have not been supplied by Paloform. Landscape stone or other natural or manufactured materials may explode when heated.



**WARNING:**

A qualified service person must connect the appliance to the gas supply. Follow all local codes.

**CAUTION:**

Use only new black iron or steel pipe. Internally tinned copper tubing may be used in certain areas. Use pipe of 1/2" diameter or greater to allow proper gas volume to Outdoor Fireplace Burner. If pipe is too small, undue loss of pressure will occur.

**INSTALLATION ITEMS NEEDED:**

Before installing the Outdoor Fireplace, make sure you have all items listed below:

- piping (check local codes)
- sealant
- manual shutoff valve
- adjustable (crescent) wrench or pliers
- sediment trap
- tee joints
- pipe wrench

**INSTALLATION REQUIREMENTS**

This appliance must be installed and serviced by trained gas installation and service technician only. All pipework must be supported and installed in accordance with local and/or national regulations.

- The gas supply to the appliance must terminate with an isolation cock and a flexible connector. This will allow the appliance to be disconnected for maintenance or repair. The appliance is supplied with a 1/2" BSP male pipe fitting.
- Check that the main gas supply line is of proper diameter to supply the required fuel pressures. Pipes of a smaller size than the heater inlet gas connection must not be used.
- If utilizing used pipe, verify that its condition is clean and comparable to a new pipe. Test all gas supply lines in accordance with local codes.
- Test and confirm that inlet pressures are correct. Refer to the heater data plate and packaging to verify fuel type.
- Install a sediment trap/drip leg for condensation which may occur at any point of the gas supply line. This will decrease the possibility of loose scale or dirt in the supply line entering the appliance's control system and causing a malfunction.

**CHECKING GAS CONNECTION**

**WARNING:** Test all gas piping and connections for leaks after installing or servicing. Correct all leaks immediately.

**WARNING:** Never use an open flame to check for a leak. Apply a mixture of liquid soap and water to all joints. Bubbles forming on joints while the gas is running indicate a leak. Correct all leaks at immediately.

**Test Pressures in Excess Of 37 mbar**

This appliance and its individual shutoff valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures in excess of 37 mbar.

**Test Pressures Equal To or Less Than 37 mBar**

This appliance must be isolated from the gas supply piping system by closing its individual manual shutoff valve during any pressure testing of the gas supply piping system at test pressures equal to or less than 37 mbar.



**WARNINGS:**

Failure to follow these instructions exactly may result in fire or explosion causing property damage, personal injury or loss of life.

---

Before operating the appliance, check all around the appliance area and on the surrounding floor for the smell of gas - some gas is heavier than air and may settle on the floor in the event of a leak. IF YOU SMELL GAS, follow the safety instructions on page 1 of this manual.

---

This appliance is equipped with an ignition device that automatically lights the pilot. Do not try to light the pilot manually.

---

The main gas valve in this appliance is not serviceable and does not have any control knobs or switches to operate. Do not remove the heat shields covering the valve and electronic devices. Do not try to repair or modify the valve, as doing so may result in a fire or explosion. Call a qualified service technician if you have any safety concerns.

---

Do not use this appliance if any part of it has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control that has been under water.

---

Improper installation, adjustment, alteration, service or maintenance can result in injury or property damage. For assistance or additional information, consult a qualified installer, service agency or the gas supplier.

---

Do not store or use gasoline or other flammable vapors or liquids in the vicinity of this appliance.

---

**INITIAL LIGHTING INSTRUCTIONS**

Before placing burner assembly into a housing:

1. Purge air from the supply line.
2. Test for leaks in each of the following locations:
  - The gas supply line connection to the main valve;
  - The Burner connections and pilot;
  - All joints on the valve and control body;
  - All field made joints and gas shutoff valves;
  - All factory made joints and connections.
3. You may check for gas leaks using one of the following methods only:
  - Soap and water solution. **WARNING:** If using a soap and water solution to test for leaks, DO NOT spray the solution onto electronic parts;
  - An approved leak testing spray;
  - An electronic sniffer. **NOTE:** Remove any excess pipe compound from connections if using this method, as the compound can set off electronic sniffers.

**DANGER: NEVER USE AN OPEN FLAME TO CHECK FOR GAS LEAKS.**

## WARNING:

This appliance is designed to be connected to a power source that is controllable by a switch.

Do not connect 24 VAC AC adapter to a live power source.

## OPERATING INSTRUCTIONS

1. STOP! Read the safety information on pages 1, 2 and 10 of this manual.
2. Turn off all electric power to the appliance.
3. Do not attempt to light the pilot manually.
4. Turn the manual gas control valve to the OFF position.
5. Wait five (5) minutes to clear out any residual gas, then check for the smell of gas at and around the appliance, including near the floor. If you smell gas, STOP! Follow the instructions on page 1 of this manual. If you do not smell gas, continue to the next step.
6. Turn the manual gas control valve to the ON position.
7. Plug the supplied 24 VAC AC adapter into a 230V power outlet.
8. Connect the AC adapter to the AC input plug at the unit.
9. Place Burner Assembly in Housing
10. To ignite burner, turn on electric power to the appliance.
11. To turn off appliance, turn off electric power to the appliance.

## TURNING OFF THE GAS TO THE APPLIANCE

1. Turn off all electric power supplied to the appliance if service is to be performed. Unplug the 24 VAC AC adapter from the power outlet.
  2. If necessary, remove the burner from the housing to access the manual gas valve.
  3. Turn the main manual shutoff valve to the full OFF position.

## KEEP YOUR FIREPLACE COVERED

Covering your fireplace burner when not in use will prolong the life of all its components.

**WARNING:** Turn off gas before servicing fireplace.

We recommend that a qualified service technician perform the following check-ups at the beginning of each fireplace season.

If any irregularities are apparent with operation. Please refer to Troubleshooting guide, pages 12-13.

## BURNER ELEMENT AND PILOT

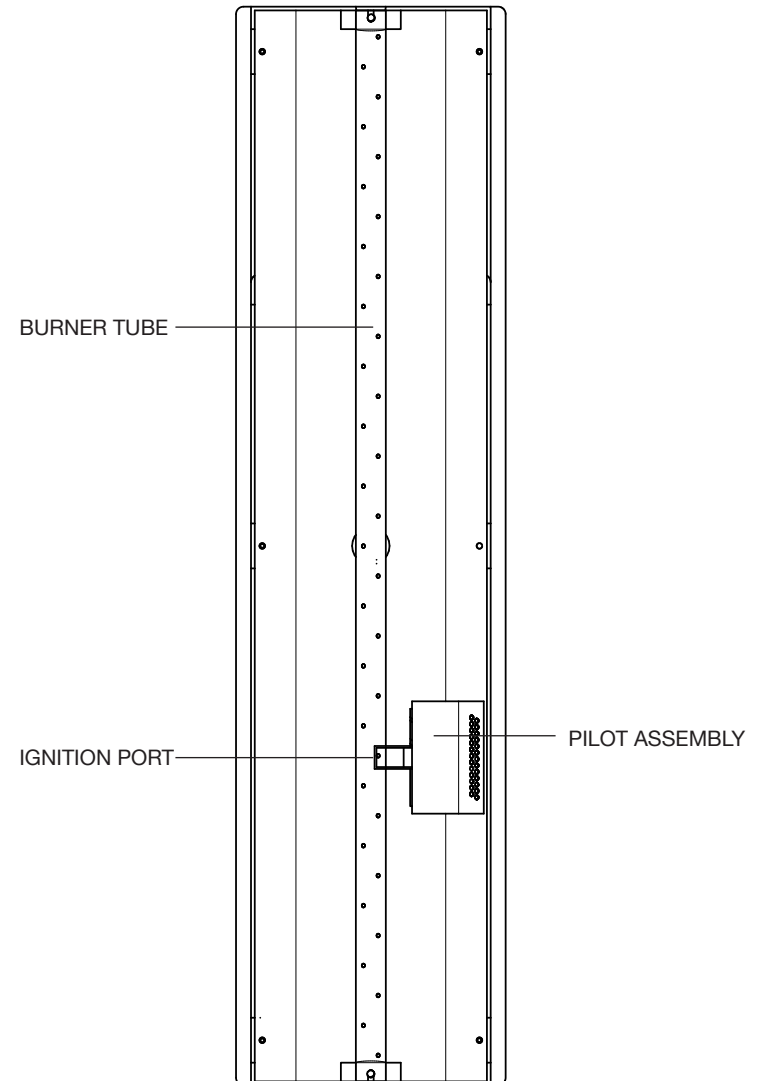
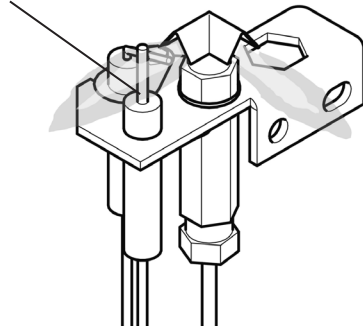
Keep the burner and pilot area clean by vacuuming or brushing at least twice a year. Make sure the burner porting and burner air openings are free of obstructions at all times. Remove pilot cover to inspect pilot.

Remove topping from top of burner ring and inspect area around the burner. Remove any lint or foreign material with a brush or vacuum cleaner.

## PILOT FLAME

The flames from the pilot should be visually checked as soon as the unit is installed, and periodically during normal operation. The pilot flame must always be present when the fireplace is in operation. The pilot flame has two distinct flames: one engulfing the flame sensor and the other reaching to the main burner.

FLAME SENSOR



**WARNING:**

Turn off appliance and let cool before servicing. Only a qualified service person should service and repair this appliance.

**IMPORTANT:** Operating unit where impurities in air exist may create odors. Cleaning supplies, paint, paint remover, cigarette smoke, cements and glues, new carpet or textiles, etc., create fumes. These fumes may mix with combustion air and create odors. These odors will disappear over time.
